

Shashi Tharoor, Baijayant Panda, Anupam Kher to take part in cultural fest 'Arth'

NEW DELHI, FEB 8 --/ Politician-writer Shashi Tharoor, BJP leader Baijayant Panda, principal economic adviser Sanjeev Sanyal, film producer Ekta Kapoor, and veteran actor Anupam Kher are among the names featuring on the fourth edition of cultural festival 'Arth', starting February 18, announced the organisers on Tuesday.

The three-day festival, touted to be India's first multi-regional fest, will be held in virtual mode owing to the Covid-19 restrictions, it said. It was held virtually last year as well. Celebrating 75 years of Indian independence, the fourth season of 'Arth - A Cultural Fest' promises to bring intriguing discussions on Indian art, culture, cinema, sports, politics, and faith to its viewers. "The last two years have been nothing but a learning curve for all of us. We have pivoted ourselves and come out even stronger. Fueled by the success of the third season of Arth A Culture Fest, we have come back with a unique theme of celebration A Celebration of India's 75 years of freedom," historian Vikram Sampath, director of the festival, said in a statement. "The fourth season of Arth promises to bring to the fore everything that has shaped India in the last 75 years, and the viewers can look forward to brilliant discussions by distinguished personalities who have represented India on a global platform," it added. Other prominent personalities taking part in the festival include actor Tusshar Kapoor, film director Vivek Agnihotri, paralympian Avani Lekhara, author Ashwin Sanghi, historian Hindol Sen Gupta and Meenakshi Jain.

In addition to the panel discussions, the upcoming season via a special TV broadcast will be telecasted on close to 20 channels of ZEE5 -- including Zee TV & Zee TV, Zee Punjabi, Zee Marathi and Zee Caf -- showcasing the brilliance of Indian culture and heritage through an ensemble of Indian dance, shayari by Kumar Vishwas, and musical performances by Aman and Ayaan Ali Khan, B Praak along with a special music ensemble by the Sa Re Ga Ma Pa team. The sessions can also be watched by the audience live on the YouTube and Facebook pages of 'Arth', the audience, they informed. The festival will come to a close on February 20. (PTT)

Nehru did not send armed forces to liberate Goa so to protect his 'peace-loving global image': Modi

NEW DELHI, FEB 8 --/ Prime Minister Narendra Modi on Tuesday blamed Jawaharlal Nehru for not sending armed forces to liberate Goa from Portuguese rule for 15 years only to protect his 'peace-loving global image'.

A week before Goa goes to polls to elect a new assembly, Modi also used his reply to the Motion of 'Thanks to the President's Address in Rajya Sabha to attack the Congress on freedom of speech and how it had sacked Lata Mangeshkar's younger brother from All India Radio for presenting a patriotic poem of Veer Savarkar. He also cited the example of noted lyricist Majrooh Sultanpuri for jailing him for speaking against Nehru. Modi also charged Nehru with leaving the satyagrahis, fighting for Goa's freedom, in lurch and using the independence address to attack their movement. "It has been 60 years of Goa liberation. People of Goa must be listening to me today. The way Sardar Patel made a strategy for Hyderabad and Junagad, if the same spirit was followed for Goa as well, then it would not have stayed under foreign rule for 15 years after India got independence. The state got liberated after 15 years of

satyagrahis. This is the torture meted out to Goa's people by the Congress party. This led to 15 years more of foreign rule in Goa. Many brave souls had to lose their lives because of this." Modi also referred to Nehru's speech on August 15, 1955, where he said that no army help would be sent to help the protesting satyagrahis and the matter would be resolved peacefully. "People of my country were left helpless, this is what they did with Goa. The people of Goa cannot forget this attitude of the Congress party," Modi added. He also attacked the Congress for meting out harsh treatment to Lata Mangeshkar's family. "Her family belongs to Goa. Let me tell how they (Congress) treated her family, the country should know that. Lata Mangeshkar's younger brother Pandit Hridaynath Mangeshkar was fired from All India Radio. His fault was that he recited a patriotic poem of Veer Savarkar. He was fired from All India Radio in eight days, this is your freedom of expression," he said, attacking the Congress party. Election for the 40-seat assembly in Goa will be held on February 14 and votes will be counted on March 10. (PTI)

Mayor hints at unlocking Mumbai by February-end as Covid-19 cases dip

MUMBAI, FEB 8 --/ Amid a significant drop in Covid-19 cases in Mumbai, city mayor Kishori Pednekar on Tuesday hinted that the Maharashtra capital will be unlocked by the end of this month and underlined the need for resumption of all activities.

The mayor's statement comes a day after Mumbai reported 356 Covid-19 cases, the lowest daily rise after December 21, 2021, when the third wave of the pandemic began, and five fatalities. The case positivity rate of Mumbai fell to 1.10 per cent, officials had said. Speaking to reporters here, Pednekar also said that Mumbai will achieve 100 per cent vaccination within a week. Quoting Brihanmumbai municipal corporation's additional commissioner Suresh Kakani, the mayor said that the city may be unlocked by the end of this month.

"It is good news for all. Everything must resume as

soon as possible," Pednekar said but cautioned citizens against lowering their guard. She said that people will have to wear face masks and maintain social distancing as per the norms.

The mayor further said that presently only one building in Mumbai remains sealed due to the detection of Covid-19 cases among its residents. "This building will be de-sealed within a few days," she added. With the Covid-19 graph falling, the civic body had relaxed some of the restrictions earlier this month.

A top BMC had said that the third wave of the

pandemic began on December 21 last year. On February 1, the Mumbai civic body had allowed all tourist locations, restaurants and theatres to operate or remain open with 50 per cent occupancy. The BMC had said that beaches, gardens and parks would be accessible to people once again during normal hours while the ban on the gathering of five or more people in public at night has been removed. These new guidelines of the BMC will remain in force till February 28, 2022. (PTI)

Families of 1,616 health workers paid insurance claims worth Rs 808 crore: Govt

NEW DELHI, FEB 8 --/ Insurance claims worth Rs 808 crore have been paid to the families of 1,616 deceased healthcare workers who were involved in fighting the Covid-19 pandemic, Union health minister Mansukh Mandaviya said in Rajya Sabha on Tuesday.

The Centre launched the 'Pradhan Mantri Garib Kalyan Package' (PMGKP) insurance scheme on March 30, 2020, for health workers fighting Covid-19. The scheme provides comprehensive personal accident cover of Rs 50 lakh to 22.12 lakh healthcare providers, including community health workers and private health workers, who may have come in direct contact with and were involved in the care of Covid-19 patients and may be at risk of being impacted by the disease. Replying to a supplementary question, Mandaviya complemented all doctors, nurses and other healthcare workers for doing exemplary work during the first, second and third wave of the

pandemic. He said the country was able to successfully handle the pandemic because of the efforts of these health workers. The minister said the government launched the PMGKP scheme to provide an insurance cover of Rs 50 lakh to eligible beneficiaries. The scheme has been extended several times. Mandaviya said insurance claims amounting to Rs 808 crore under this limit of Rs 50 lakh have been paid to families of 1,616 health

workers. In a written reply, Mandaviya said 201 compensation claims amounting to Rs 100.5 crore had been paid in Maharashtra till January 2022. As many as 160 claims amounting to Rs 80 crore were paid in Andhra Pradesh. To another query during question hour, the minister said health is a state subject and the related data is collected by the states and then reported to the central government. Mandaviya said the WHO has issued guidelines on collecting the data on Covid-19 deaths. Based on these guidelines, the Centre has created a platform and asked the states to submit the data on Covid-19 deaths on it, he added. So far, all the state governments have submitted data of over 5 lakh deaths caused by Covid-19, Mandaviya said, asserting that the Centre has nothing to hide.

The Centre has also asked states to reconcile the data if they failed to submit it, he said, adding that many states have done that. "We

Maharashtra: Senior citizen booked for cheating relative of Rs 4 lakh with promise of job

THANE, FEB 8 --/ An offence has been registered against a 75-year-old woman for allegedly cheating her relative of Rs 4 lakh by promising to get him a job in the Kalyan civic body in Maharashtra's Thane district, police said on Tuesday. A case under section 420 (cheating) of the IPC has been registered against Suman Wakle, an official from Badlapur police station said. According to the police, the complainant's son had approached the accused seeking employment in August 2016, and the latter informed him that her son had got a job in the Kalyan-Dombivli municipal corporation (KDMC) by paying Rs 4 lakh. The accused took Rs 4 lakh from the complainant's family, but didn't get the man a job or return the money, the official said, adding that further probe is underway. (PTI)
